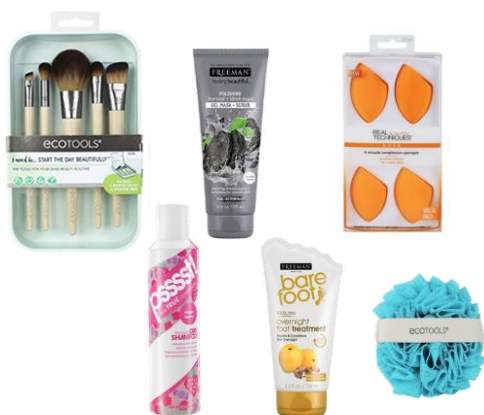

- Marketed in the food, drug, mass, and specialty beauty retail sectors, in addition to e-commerce channels

- Quadrupled revenues while increasing EBITDA by more than five times
